

SUMMARY ANNUAL REPORT FOR UNIVERSAL MUSIC GROUP HEALTH AND SECURITY BENEFITS PROGRAMS

This is a summary of the annual report of the UNIVERSAL MUSIC GROUP HEALTH AND SECURITY BENEFITS PROGRAMS, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 13-2613071, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

UMG RECORDINGS, INC. has committed itself to pay certain Medical, Dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with DELTA DENTAL OF CALIFORNIA, KAISER FOUNDATION HEALTH PLAN INC, VISION SERVICE PLAN, HARTFORD LIFE AND ACCIDENT, CCA INC and NATIONAL UNION FIRE INS. CO. OF PITTSBURGH, PA. to pay certain Dental, Health, HMO contract, Vision, Life insurance, Temporary disability, Long-term disability, Worksite Benefits, CI, Accidental Death and Dismemberment, and EAP claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$6,137,873.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$506,928 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$2,525,492.
